- 2. <u>Specific Asset</u>: I give, devise and bequeath my Salvador Dali, Limited Edition Lithograph entitled "Celestial Elephant" to the Oregon Women Lawyers Foundation of Portland, Oregon, tax ID #91-1770055, an Oregon nonprofit corporation, to be used for its general charitable purposes.
- 3. <u>A Percentage of the Residue</u>: I give, devise and bequeath 10% of my residue to the Oregon Women Lawyers Foundation of Portland, Oregon, tax ID #91-1770055, an Oregon nonprofit corporation, to be used for its general charitable purposes.
- 4. Residue: I give, devise and bequeath the remainder of my residue to the Oregon Women Lawyers Foundation of Portland, Oregon, tax ID #91-1770055, an Oregon nonprofit corporation, to be used for its general charitable purposes.
